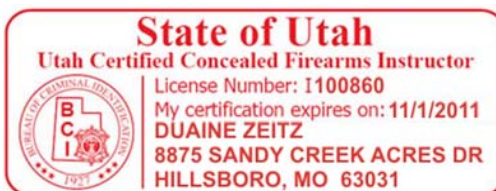

Topics Covered and Exercises Performed:

- ⊖ Firearm safety in the home, on the range and while carrying or transporting the firearm.
- ⊖ Demonstrations by the student proving their ability to safely handle, load, un-load and shoot both a revolver and a semi-automatic pistol.
- ⊖ The basic principles of marksmanship for both target shooting and self-defense.
- ⊖ The care and cleaning of firearms.
- ⊖ Proper storage of firearms in the home.
- ⊖ Requirements of the state to purchase, sell or otherwise transfer ownership of a concealable firearm.
- ⊖ Requirements of the state to obtain a concealed carry endorsement.
- ⊖ How to obtain legal advice on firearm laws and the justifiable use of force. The student was provided with a copy of chapters 563 and 571, RSMo.
- ⊖ What to expect from their own reactions to stress in an emergency.
- ⊖ This student in the standing position performed a live fire demonstration of no less than fifty rounds. The student fired both the revolver and the semi-automatic pistol in a safe and effective manner. This student passed a live fire test of 20 rounds exceeding the 75% requirement. This student clearly demonstrated, in my presence, their ability to place a minimum of 15 out of 20 shots within the "black" portion of the equivalent of a B-27 target at a distance of seven yards.
- ⊖ A curriculum vitae was issued to this student detailing many more topics.
